#### HOW TO USE KOLOR-SAFE® LIQUID BASE NEUTRALIZERS:

1. Evacuate employees from the spill area.
2. Wear personal protective equipment compatible with chemicals involved.
3. Ventilate the contaminated area.
4. Contain the spill with universal sorbent material.
5. For best results place universal sorbent pads on the spill to soak it up.
6. Slowly spray or pour the base neutralizer on the spilled caustic.

CAUTION: Some HEAT or GASSING OUT may be generated.

1. The color change indicator changes from RED to BLUE during neutralization. Color change must occur.
2. Apply liquid base neutralizer until the color change indicator first turns a yellowish color. Do Not Over-Neutralize.
3. Allow neutralized liquid to cool.
4. Soak up remaining neutralized liquid with sorbent materials.
5. Place used sorbents into temporary disposal bags.
6. Wipe up residue with non-woven cloth material.
7. Dispose of all used articles (sorbents, neutralized liquid, etc.) according to local, state and federal regulations.

NOTE: Depending on the extent of the clean-up process, additional equipment may be required.
